### **SWT Council priorities**

Somerset West and Taunton Council's updated priorities during the coronavirus outbreak are as follows:

- Preserve critical services;
- Safeguard the public;
- Ensure our most vulnerable residents are supported; and
- Planning economic resilience and recovery

The situation is being reviewed on a daily basis to ensure that the Council follows the <u>latest advice from Public Health England</u>.

# Key Messages this week

### 1. SWT aims to create Community Chest Fund

SWT is aiming to create a new fund to help communities recover from the effects of COVID-19. The proposed Community Chest of £250,000 would be used to support one-off initiatives that contribute to COVID-19 recovery and community cohesion across the district.

The grants are intended to supplement activities and projects run by the voluntary and community sector and wider community groups who are not able to secure mainstream funding from the Council or other sources. One-off grants of up to £5,000 could be awarded, covering up to 75% of the total cost with applicants needing to find at least 25% from their own or other sources, which can include an in-kind contribution.

The Community Chest Scheme would give consideration to initiatives that will help community groups to become sustainable in the longer term; that will help the community to recover from the effects of COVID-19; and are aligned to SWTs corporate priorities of housing and communities, the environment and the economy.

The Council's Scrutiny Committee has considered the report and recommended that the Executive approve the creation of a Community Chest when it meets on 23 September.

### 3. Somerset West Lottery autumn bolt-on prize

#### 4. Dulverton Weir made winter-fit

After emergency work in June, SWT returned to Dulverton Weir to carry out more significant repairs to prepare it for the winter. Heavy equipment was used to reposition hefty boulders in the weir and fill in holes that had developed during the year. It is envisaged that these repairs will solve the problem of the leat running dry for the immediate future but the Council team will return to carry out more work if necessary.

#### 5. Reminder parking charges resumed

Charging was reintroduced in Somerset West and Taunton owned car parks on Monday 31 August. The Council introduced free parking at the start of the coronavirus lockdown and extended the offer as part of its wider plan to support the re-opening of High Streets and help rejuvenate the local economy.

It has taken the decision to start charging again in line with other district councils in Somerset, although key health workers, on duty who display permits provided by their NHS Trust can continue to park for free. 6. # 7. SWP resumes kerbside collections for "wearable" shoes and clothes only.

Kerbside collections of clothes and shoes started again this week, but with tough new conditions. No textiles - bedding or curtains - will be taken, and the clothes and shoes must be of good enough quality to be worn again. Anything of lesser quality should be considered for other uses at home - such as cleaning rags or cloth wipes. Failing that, it should be put in the rubbish and will go to a new Resource Recovery Centre where it will be used to generate electricity.

Somerset Waste Partnership (SWP) is committed to recycling or reusing everything it collects. These new conditions reflect the near-collapse of the global second-hand market caused by COVID-19 and the rise of disposable fashion.

Textile collections have been suspended in Somerset since April, when COVID-19 saw the national and international markets grind to a halt. While charity shops are normally the best route for good quality textiles, clothes and shoes, many are currently limiting the donations they accept because of the complications that have come with COVID-19.

# Partner Engagement - Key messages from other Public Service Areas

### Somerset County Council (SCC)

### **Highway Maintenance Update**

SCC Highways are currently focusing on the routine tasks of gully emptying, safety defect repairs and patching. You may well also see the carriageway surface dressing team out and about, carrying out aftercare tasks on the dressings that were laid in June.

A much quieter week last week after the unseasonable storms "Ellen" and "Francis" of the preceding fortnight. SCC have now completed the rural verge maintenance programme with the second cuts of the "A" and "B" road network. Readers will have noticed, though, that grass cutting is still continuing in the towns and built up areas. This work is carried out by the district, town and parish councils, where a greater frequency of cutting is desirable, both from an aesthetic point of view and to also assist with such tasks as litter picking.

On rural roads, cutting is done to maintain sight lines, remove obstructions, and provide a margin for pedestrians to step onto if required and to help the flow of water along road channels. It is done with a flail mounted on the back of a tractor.

In urban areas, where the cutting is more frequent and to a shorter length, the operation is carried out with much smaller, more agile equipment such as sit-on rotary mowers.

# M5 Junction 25 Improvement Scheme Update Bulletin - Ruishton Lane

In a previous Newsletter SCC advised that Ruishton Lane would be closed during August for 5 weeks. This would allow Wessex Water to upgrade their system.

Following excavation and inspection by Wessex Water, there is an area of old pipe work that was not shown on the existing utility drawings. These pipes are still live and need to be replaced. Therefore, it has been agreed with Wessex Water to replace this pipe work now. This will ensure continuity of water supply and minimise the disruption for local residents/businesses in the future. This means the closure of Ruishton Lane will need to be extended until Tuesday 29 September 2020 to complete this essential work and reinstate the road.

Pedestrian and cycle access will be maintained and a diversion route for traffic will be clearly signposted. The diversion route will be via Cheats Road, Lipe Lane and the A358. The Diversion route shall remain in place until completion of this work.

# Toneway Creech Castle Junction phase 1 early works to begin on 7 September

Advance works to improve cycling and walking facilities near the busy Creech Castle junction in Taunton are due to start soon.

The main Toneway Creech Castle Junction scheme was initially planned to start in April 2020, but was postponed due to the coronavirus outbreak. It was then agreed to delay the scheme until summer 2021 to support the local economy as it recovers post lockdown. This remains the case, but Alun Griffiths are bringing forward some of the advanced works to improve pedestrian and cycling facilities on the north and south route along the A38 Bridgwater Road. They will also be delivering improvements to Hyde Lane which has long been subject to flooding and subsidence. Additional drainage will be installed and a new improved carriageway surface to address these issues. Hyde Lane will be closed from 7 September 2020 for 4 weeks from the turn at Hyde Lane Cottages for approximately 200m.

#### What will the work include?

**Cycle and pedestrian improvements** will begin on the **7 September** until Christmas 2020, the works will consist of:

- Widening of the footway along the A38 north of the junction for a length of approximately 500m
- Provision of off road and on road cycle ways, including the provision of a new Toucan Crossing;
- Provision of associated lighting and way-finding signs; and Carriageway Surfacing.

## **FAQS**

## Q. What activities and out-of-school clubs can my child attend?

A. Providers who run community activities, holiday clubs, after-school clubs, tuition and other out-of-school provision for children can now operate with <u>protective measures</u> in place. Children are able to attend settings such as

tuition and learning centres, many types of extracurricular clubs (e.g. dance classes, gymnastics training, football coaching), uniformed youth organisations (e.g. Scouts, Guides and cadet forces), supplementary schools, private language schools and religious settings offering education (for example madrassahs, yeshivas, and Sunday schools), provided they are only operating in premises legally able to be open.

# Q. Can I attend an out-of-school setting to watch my child in a live performance?

**A.** Live performances are currently permitted but only where strict coronavirus security measures are able to be implemented safely. This includes for the performers, the audience and anyone supporting the performance.

Ahead of attending, you should check with the provider organising the live performance what steps have been taken to mitigate the risk of transmission. The protective measures providers put in place should be in line with those outlined in the <u>performing arts guidance</u>, for example limiting the size of the audience to allow social distancing to be maintained and only operating in a venue with adequate ventilation.

### WANTED: New PCSOs to join Avon and Somerset Police

Police Community Support Officers (PCSOs) are part of neighbourhood police teams and work with colleagues from across the organisation to reduce crime and provide a visible and reassuring presence in neighbourhoods. They build relationships with local people to understand the policing issues that matter to them most and work with schools, colleges, community leaders, businesses and other groups to listen, engage and provide support on a wide range of policing issues. PCSOs are community champions and problem solvers who make a positive impact.

Avon and Somerset Police launched a campaign to recruit new PCSOs on the 3 September. They are seeking talented people from a wide range of backgrounds for a rewarding career where they can be the difference by playing a vital role in supporting, protecting and engaging with local communities.

### Tougher fines for serious breaches of coronavirus restrictions

Tougher measures targeting the most serious breaches of social distancing restrictions have now come into effect. If you're organising an illegal rave, unlicensed music event, or any other unlawful gathering of 30 people or more, you could face a £10,000 fine. Fines of £100 can continue to be issued to those who participate in illegal gatherings and those who have already received a fine will see the amount doubled on each offence, up to a maximum of £3,200.

For your safety and the safety of others, do not attend unlawful events. They are not organised with your safety in mind.

#### Police will take action against unauthorised Car Meets

Unauthorised car meets can cause significant impact on local residents and businesses and tackling the issue is a top priority for the A&SP neighbourhood teams.

Early intervention is key to preventing community tension and managing any potential issues with anti-social or illegal activity
